



## **DATA PRIVACY STATEMENT**

### **BOOKING A ROOM SERVICE**

We care about your privacy. We have strict safeguards to prevent anyone from accessing your personal information. We do not disclose personal data to third parties.

The EU is committed to data privacy. Protection of individuals with regard to the processing of personal data is based on European Parliament and Council [Regulation \(EC\) No 45/2001](#).

#### **Description of the Service**

The Representation of the European Commission in the UK is part of the Directorate General for Communication of the European Commission. The Representation offers spaces for organisations to hold events related to Europe at the Europe House. Personal data is therefore collected to ensure proper communication with the requester and follow up of the event.

#### **What data do we collect?**

We only collect the personal data necessary for the delivery of the ordered resources:

- Name
- Organization
- Telephone number, email address
- Permission (yes/no) to be entered in mailing lists

#### **Who has access to your data?**

A limited number of employees in the European Parliament Information Office and the Representation of the European Commission in the UK have access to your personal data. These employees are working in the fields of communication and events organization. We do not disclose any personal data to third parties.

#### **How is your data stored?**

Your personal data is stored on our computers managed by the Directorate-General for Informatics [DIGIT](#) of the European Commission and Directorate-General for Communications, Local System Administrator's team (LSA team) of the European Parliament. The rules on confidentiality and protection of personal data [Regulation \(EC\) No 45/2001](#) are respected during processing.

#### **How long do we keep your data?**

Your personal data is kept in our databases until one year after the event date to allow contacts with the organizer of the event for the organization and follow up of the

event. After this delay, all data that may allow identifying you will be deleted, while anonymous data that can be useful for statistical purposes is kept.

If you give permission to be entered in a mailing list, your data is kept unless you ask to be unsubscribed.
